Buyer agrees to pay a 20% restocking fee for orders cancelled with less than 24 hours notice. Buyer further agrees that in the event suit is necessary to recover payment of the purchase price, the site of venue will be Sumter County, Florida, and Buyer will pay Seller's attorney fees and costs including attorney fees to appeal. Buyer expressly waives all right of exemption under the constitution and laws of the State of Florida and any other state or jurisdiction as to personal property and Buyer agrees to pay all costs of collection or attempting to collect or secure any and all debts which Buyer now owes or which Buyer may in the future owe Seller for goods sold Buyer or for services rendered including a reasonable attorney's fee on the unpaid debt so long as any of said indebtedness is due and unpaid. In consideration of the extension of credit, Seller has a lien on all product and property of Buyer in its possession until payment of its bill in full.

For the benefit of both landscape contractors and Sumter Gardens Tree Nursery, we will request information as to the developer (owner), general contractor and lender on all job sites where we deliver material on credit. A release of lien will be issued upon full payment of the account.

Florida law governs the sale of goods and/or services. Seller's liability for any damages claimed by Buyer is limited to the purchase price of goods or services in question.
